PROJECT DESCRIPTION

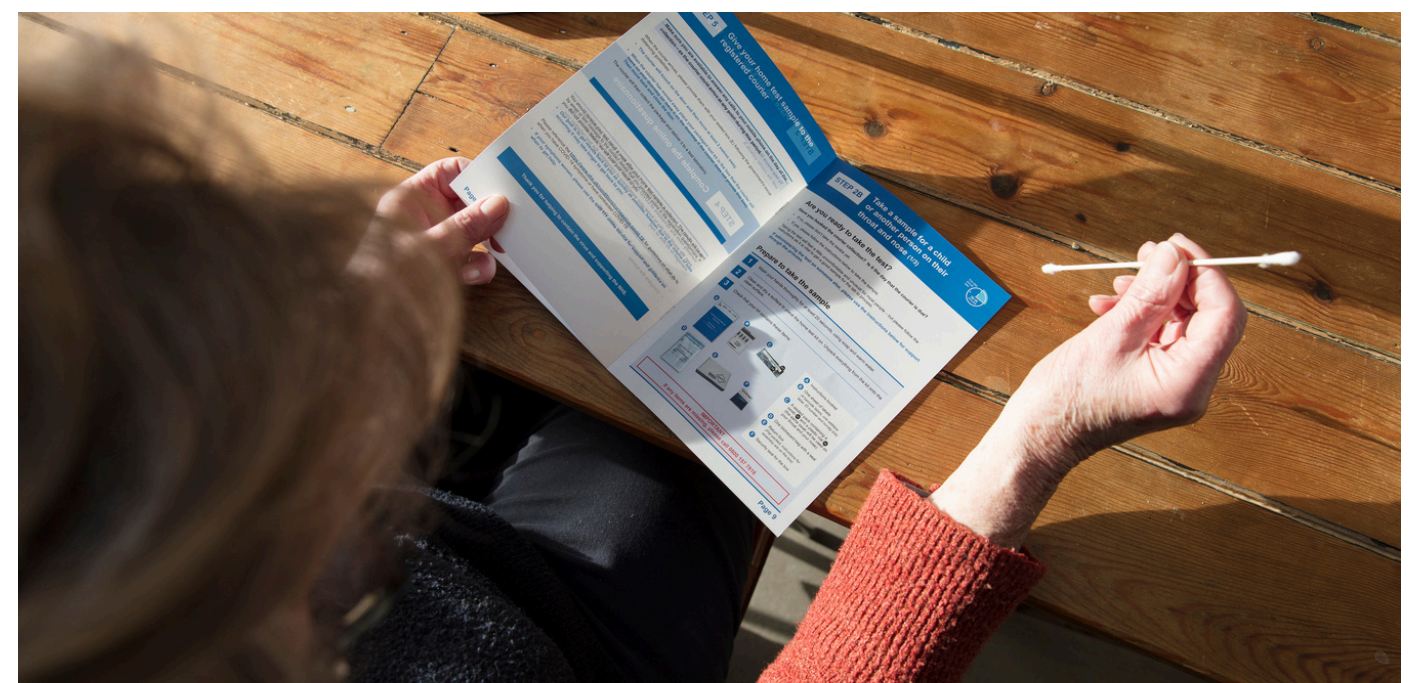
The SOER 2021 report by the European Environment Agency highlights urgent issues like biodiversity loss, climate change, and resource overconsumption in Europe, calling for a shift towards Sustainable Development. The economic focus in the job market hinders the VET sector's ability to address these social and environmental priorities effectively.

Integrating Sustainable Entrepreneurship Education (SGE) into the curriculum can equip students with the skills to become eco-friendly entrepreneurs while promoting social responsibility and environmental protection.

Objectives include:

- Developing a 'Sustainable Entrepreneurship Education' training module using Project-Based Learning (PBL) for vocational schools to train eco-friendly entrepreneurs.
- Increasing students' awareness of the three basic dimensions of Sustainable Development (Ecological, Social, and Economic).
- Creating an e-booklet of Entrepreneurial Best Practices addressing sustainable development in partner countries.
- Helping students understand the national and international implications of personal actions.
- Facilitating the exchange of skills and ideas among participants.
- Supporting students in becoming greener thinkers and entrepreneurs.

PROJECT RESULTS



We aim to create 2 main results:

RESULT-1: A training module called 'Sustainable Entrepreneurship Education' using Project Based Learning (PBL) training approach to be used in vocational high schools in order to support the training of more eco-friendly individuals/entrepreneurs.

RESULT-2: An e-booklet of Entrepreneurial Best Practices addressing all 3 key dimensions of sustainable development in partner countries.
